Section 4 - First Aid Measures

Eye contact

In case of fire on tank:

- Evacuate immediately if pressure relief device makes a noisy sound or the color of tank changes.

- Evacuate from the tank in flames.

- In case of large fire: Use unmanned equipment. If it's impossible, retreat and let it burn.

- Water, scattered when the container is heated or exploded, may burn the skin or eyes.

If there is no risk, take actions to stop the leakage.

Methods and material for containment and cleaning up

For small amounts: Pick up with suitable absorbent material.

For large amounts: Dike spillage. Pump off product.

Wash contacted area thoroughly after usage.

Since emptied containers may retain product residue, follow MSDS/label warnings even after containers are emptied.

Avoid prolonged or continuous skin contact.

Be aware of the substances and conditions to avoid.

Handle in accordance with engineering control and use personal protective equipment.

Conditions for safe storage, including any incompatibilities

Containers should be kept closed in order to minimize contamination.

Store in a cool, dry, well ventilated place protected from light. Keep away from extreme heat and from freezing conditions and away from all sources of ignition. Make sure the material does not come into contact with substances listed as: "Materials to Avoid".
