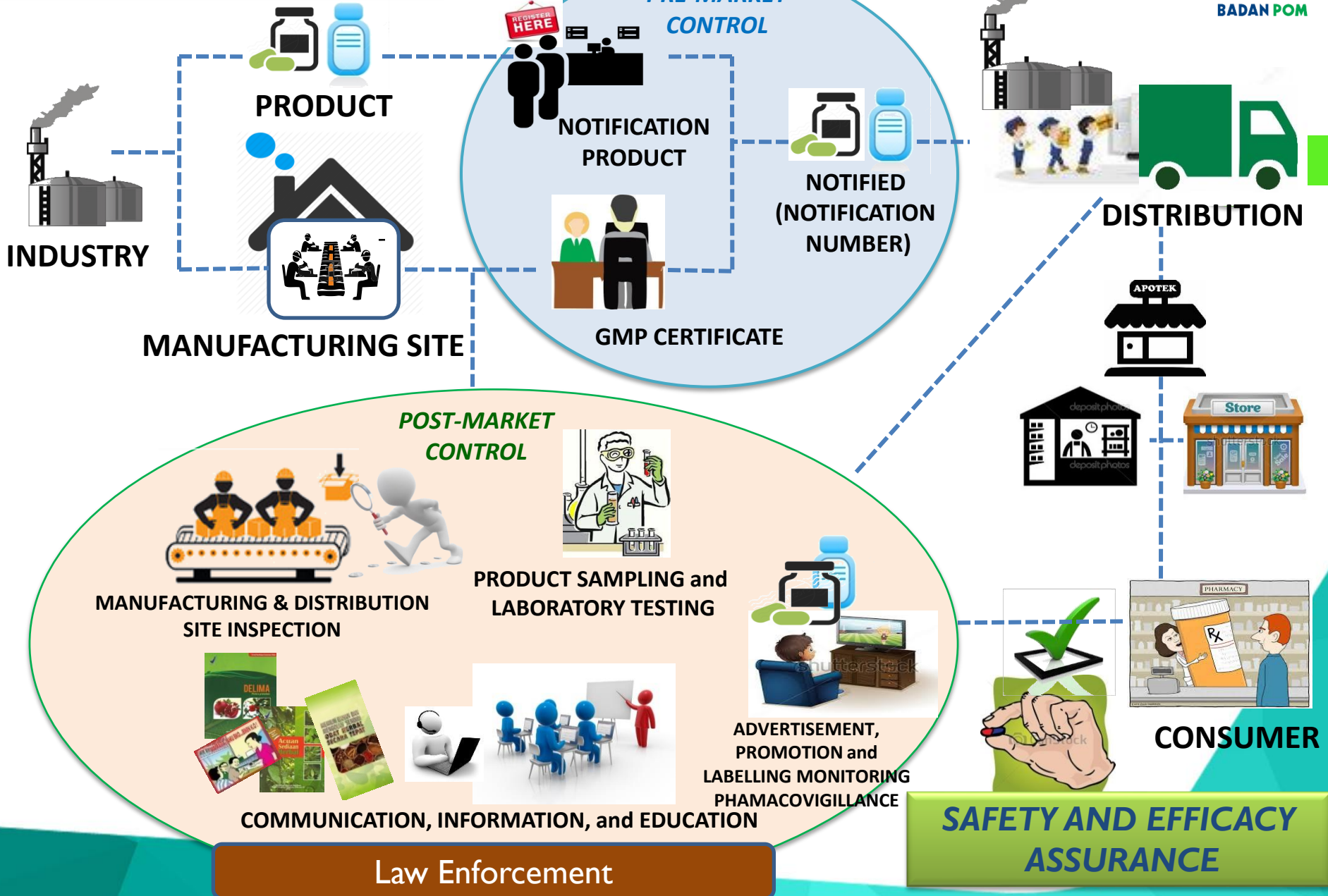
Vision

Definition of Cosmetic

- x A cosmetic product shall mean “any substance or preparation intended to be placed in contact with various external parts of the human body such as **epidermis, hair system, nails, lips and external genital organs**) or with **teeth** and the mucous membranes of **the oral cavity**, with a view exclusively or mainly to cleaning them, perfuming them, changing their appearance and/or correcting body odours and/or protecting them or keeping them in good condition”

Cosmetic Regulatory Framework (Indonesia overview)



Basic of safety requirements

- Must not cause damage to human health when applied under normal or reasonably foreseeable condition of use
- Manufacturer has to gather the necessary technical information
- Component & finished product evaluated for aspect of safety
- Products produced under GMP
- Safety data available
- Labeling meets requirement

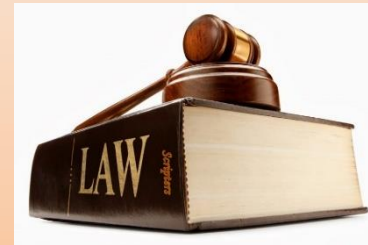

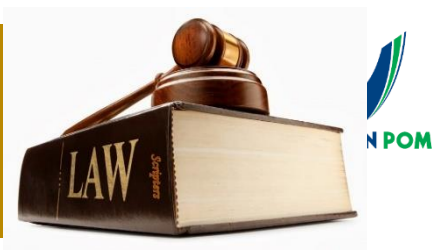

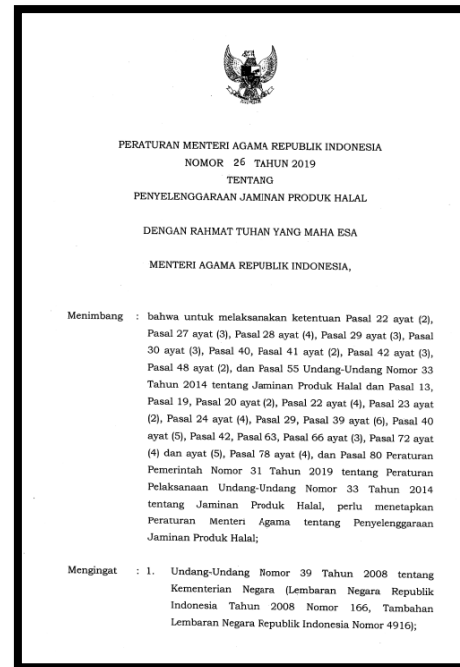

HALAL COSMETICS



Cooperation Between Indonesian FDA and BPJPH

based on Government Regulation No. 31 of 2019 concerning Implementation Regulation of Law No. 33 of 2014 concerning Halal Product Guarantee

- a. **Halal certification** for drugs, traditional medicines, cosmetics, health supplements, and foods;
- b. **Halal Products controlling** for drugs, traditional medicines, cosmetics, health supplements, and food in the market;
- c. **Recommendation for revocation of halal certificate** of drugs, traditional medicines, cosmetics, health supplements, and foods;
- d. **Socialization, education, and publication** related to drugs, traditional medicines, cosmetics, health supplements, and foods;
- e. **Other duties** related to administering JPH according to their respective duties and functions.

HALAL COSMETICS

- **Halal cosmetics certification process** → *Badan Penyelenggara Jaminan Produk Halal/Halal Product Assurance Body (BPJPH)*
- For cosmetics, **there are no evaluation on labelling prior to notification** → **Claims of halal cosmetics must be proven by halal certificates** → Post Market Evaluation
- Indonesian FDA is now drafting regulation concerning **labelling for cosmetics containing pork** → listed in the draft of Indonesian FDA Regulation concerning Technical Requirement on Labelling for Cosmetic Products



HALAL COSMETICS

Labelling for cosmetics containing pig/porcine

Warnings must be printed on the label:

- for Cosmetics containing ingredients originating from pigs must include a special sign in the form of black writing in Indonesian "**MENGANDUNG BABI**" in a black box on a white base, as follows:

MENGANDUNG BABI *

***Contain pig**

- for Cosmetics which its manufacturing process contact with material originating from pigs must include black writing in Indonesian "**Pada proses pembuatannya bersinggungan dengan bahan bersumber babi**" in a black box on a white base, as follows:

**Pada proses pembuatannya bersinggungan
dengan bahan bersumber babi** *

* **Manufacturing process contacts with material originating from pig**

HALAL PRODUCT ASSURANCE (LAW 33/2014)

- Article 1 Product are goods and/or services that are related to food, beverage, drug, cosmetic, chemicals product, biological product, genetically engineered product, as well as consumer good that are worn, used, or utilized by the public .
- Article 4 Products that enter, circulate, and are traded in the territory of Indonesia must be halal certified.
- Article 26
 1. Business Operators that produce Product from Material that comes from haram Material as intended in Article 18 and Article 20 are excluded from submitting Halal Certificate application.
 2. Business Operators as intended in paragraph (1) must attach non-halal information on the product.

PROVISION (LAW 33/2014 ARTICLE 1)

Definition:

- Product are goods and/or services that are related to food, beverage, drug, cosmetic, chemicals product, biological product, genetically engineered product, as well as consumer good that are worn, used, or utilized by the public.
- Halal product is the product that has been declared halal lawful according to Islamic shariah.
- Halal Product Process (HPP) is a series of activity to assure the halalness of the product including material procurement, process, storage, package, distribution, sales and presentation of the product
- Material is Ingredients used to produce or manufacture the product.

GOODS AND SERVICES

- Product is goods and/or services (Article 1 verse 2, Gov. Regulation 31/2019)
- Goods : food, beverage, medicine, cosmetic, chemical product, produk biological product, genetical engineering product, and usefull goods that be used or be functioned by people. (Article 1 verse 2, Gov. Regulation 31/2019)
- Services : Business that be related to goods and their chain. (slaughtering, processing, storing, packaging, distributing, sale, and serving). (Article 68 verse 3, Gov. Regulation 31/2019)

THE STEP OF HALAL MANDATORY

- The halal mandatory started at 17th of October 2019 with 5 years guidance period until 17th of October 2024.
- Food and beverages must be halal certified after 5 years the halal mandatory started 17th of October 2019.
- Except food and beverages product, the halal mandatory **started at 17th of October 2021 with guidance period various years (7, 10, 15 years).**

INTERNATIONAL COOPERATION

- International cooperation of BPJPH with Halal Certification Body (HCB) basically based on Government to Government (G to G cooperation)
- The government can make international cooperation about Halal in accordance with the law (Law 33/2014 Article 46 verse 1).
- Halal Certificate recognition be in the form of the cooperation to recognize Halal Certificate (Gov. Regulation 31/2019 Article 26 verse 3), who do by the foreign halal agencies authorized to issue Halal Certificate (Gov. Regulation 31/2019 Article 26 verse 4).
- Foreign HCB who are publishing Halal certificate established by the government or Islamic religious institutions recognized by the local government (Gov. Regulation 31/2019 Article 27).
