ESSENTIAL OILS AND RESINOIDS; PERFUMERY, COSMETIC OR TOILET PREPARATIONS (HS code(s): 33); Cosmetics. Toiletries (ICS code(s): 71.100.70)

- **Title, number of pages and language(s) of the notified document:** The Cosmetic Products (Restriction of Chemical Substances) Regulations 2024; (3 page(s), in English)
- **Description of content:** These measures will amend the Cosmetics Regulation 1223/2009 as applicable in GB ("the Cosmetics Regulations") as they apply in [England, Wales and Scotland]. They will amend permitted levels of certain chemicals in the Cosmetics Regulations.

We will be amending the Cosmetics Regulations to permit the use butylated hydroxytoluene (BHT) up to a maximum concentration of 0.1% in toothpastes, 0.001% in mouthwashes and other leave-on oral care products, and 0.8% in all other cosmetic products.

7. Objective and rationale, including the nature of urgent problems where applicable: The Cosmetics Regulations contain technical annexes that establish limits and prohibitions on the use of specified chemicals. The Government has powers to amend the various annexes when certain conditions are met. The objective of the measure is to

amend the permitted use of specific chemicals in order to ensure that only cosmetics products that are considered safe can be placed on the GB market.

The measure requires amending the technical annexes of the cosmetics regulations to change the permitted level of use of a specific chemical. This decision has been informed by the expert advice of the Scientific Advisory Group on Chemical Safety (SAG-CS). The SAG-CS' primary purpose is providing the UK Government with independent scientific advice on chemical risk.

Government has considered the recent advice from SAG-CS and made the decision to amend the Cosmetics Regulations on the use of butylated hydroxytoluene (BHT), allowing BHT to be used up to a maximum concentration of 0.1% in toothpastes, 0.001% in mouthwashes and other leave-on oral care products, and 0.8% in all other cosmetic products. ; Protection of human health or safety
